Overpayment write-offs

In our last newsletter we highlighted that, following representations by CSPA NI and others, Civil Service Pensions (CSP) had had 60 civil service overpayment cases written off.

In August we were notified by CSP that they had identified a further seven overpayment cases, ranging from £5,500 to £65,000 and totalling £152,000.

Although the seven pensioners had to move to the recalculated pension, we were pleased that the overpayments themselves were written off on the same basis as the previous 60 had been.

Active Ageing Strategy update


CSPA NI wrote to Northern Ireland's Department for Communities (DfC), seeking an update on the Active Ageing Strategy (AAS).

In reply, DfC said the AAS had originally been issued in 2016 but had been updated in 2020 and extended until the end of the last Assembly mandate – May 2022.

The refreshed strategy updated on existing actions, included new actions that had not featured in the original strategy but contributed to the wellbeing of older people, and pointed to actions in response to Covid-19. As to the development of the AAS, key stakeholders took part in a series of workshops in 2022, which considered

the problems the strategy could address, produced a longlist of actions and prioritised them.

There was also direct engagement with a range of older people about their lived experiences and identified areas for consideration in any new strategy. This will not recommence until the appointment of a new DfC minister in any future Northern Ireland Executive.

Commissioner for Older People attends meeting with CSPA NI

The meeting discussed items of concern including ageism, the triple-lock on state pensions, the impact of the pandemic on older people, and the proposed changes to public transport concessionary fares.



As reported in the Autumn issue of *The Pensioner* magazine, Eddie Lynch has succeeded in a legal challenge to a decision of the NI Department of Health that would have denied funded healthcare to many pensioners on the basis of their response to a new question on whether the individual's healthcare needs "could be met properly in any other setting than a hospital".

The judge quashed the policy on the basis that it was adopted "in breach of its obligations to have due regard to the need to promote equality of opportunity between persons of different ages".

The CSPA is campaigning with other pensioner organisations for a Commissioner for Older People in England, and one in Scotland, to independently promote the interests of older people and challenge government policies where necessary.

2024 pension increases

On 18 October, the Office for National Statistics (ONS) announced that the Consumer Prices Index (CPI) for September remained at 6.7%.

The annual civil service pension increase, due in April 2024, is underpinned by a statutory link to the inflation rate in the preceding September, which means civil service pensioners in Northern Ireland should see their pensions increase by 6.7% from next April.

The ONS September statement should also mean that the state

pension increase, also due in April 2024, should rise by the higher savings growth figure of 8.5%.

This is in line with the triplelock, which links the state pension increase to CPI inflation, savings growth or 2.5%, whichever is the highest figure.

In September, the ONS confirmed

State pensioners should see their pension increase by 8.5% from April 2024 that average earnings, including bonuses, had risen over the 12-month period by 8.5%. As the government has committed to retaining the triple-lock for the remainder of this parliament, state pensioners should see their pension increase by 8.5% from April 2024.

Although these rises may sound generous given the rate of pay increases, which have been particularly low in the public sector, readers should remember that the UK state pension is the second worst in Europe.

National AGM report

The national CSPA AGM took place in Kenilworth, near Coventry on 11 and 12 October. The Northern Ireland Branch was represented by delegate Harry Baird, observer Ivan Baxter and NI National Council representative Tony McMullan. Branch Treasurer Roisin Lilley also attended as a nationally elected women's representative.

The Branch's motion calling for the creation of a national social care service similar to the National Health Service was proposed by Harry Baird and carried unanimously.

Harry highlighted that there had been a continual failure of both

the Westminster and devolved parliaments to deliver a fully costed and comprehensive social care systems throughout the four UK countries. He added that this was of critical importance and demanded that a national social care system be established with national standards but designed and developed within the framework of the devolved UK nations.

Among the other topics debated at the AGM were pensions and related matters, digital exclusion, transport, photo ID, artificial intelligence, health, banking hubs, telephone scams and internal CSPA recruitment strategies.

NI Assembly All Party Group

Although the Northern Ireland Assembly is still not functioning, its all-party groups continue to meet and plan activities.

The group focusing on older people, on which the CSPA NI has observer status, met on 9 October. Age NI Director Paschal McKeown presented the organisation's latest Lived Experience Survey, with its underlying commitment to equal access to corporate healthcare.

Among the many other issues discussed were GP services, waiting lists, ageism, prevention and early intervention, and a review of adult care.
